

Trail Protection Grants Guidelines and Application

Funding to Permanently Protect the North Country National Scenic Trail

The North Country Trail Association Trail Protection Grant has been established to provide funding to permanently protect the corridor and hiking experience of the North Country National Scenic Trail. Grants may be applied toward costs associated with trail protection research, the acquisition of Trail Access Easements (TE; "Rights of Way"), and in some cases, the acquisition of Conservation Easements or land full ownership of land. The size of each grant is limited by the funds available, competing needs for such funds, NCTA land interest acquisition policy, and NCTA operating standards & procedures. NCTA's Director of Trail Protection reviews all requests under the supervision and approval of NCTA's Trail Protection Committee (which meets monthly) and NCTA's Executive Director. Some requests may also require direct Committee approval and/or NCTA Board approval.

Application

Applications may be requested and submitted by NCTA staff, NCTA Chapters, NCTA Affiliates organizations and agencies, and other partnering agencies or organizations as deemed appropriate by NCTA. In reviewing qualifying grant requests, the Director of Trail Protection, Trail Protection Committee, and NCTA Board of Directors (as the case may be) will consider the following:

- Use of Trail Protection Funds demonstrably adhere to NCTA's adopted non-profit policies, standards, practices, and trail protection strategies;
- Trail establishment and siting will follow guidelines established by the National Park Service, to the extent possible.
- Some evidence of a need for funding has been established.

Priority will be given to projects that:

- Protect both the trail corridor and the hiking experience surrounding it;
- Permanently protect the Trail (99 years in North Dakota) and any land interests acquired through the use of the funds;
- Are identified as high priorities within NCTA's Trail Protection Strategy;
- Protect sections of Trail identified as within a Trail route identified in NCTA & NPS planning processes;
- Account for the long-term stewardship of the Trail corridor and/or land;
- Connect existing Trail segments;
- Protect particularly vulnerable Trail corridors;
- Protect existing but unprotected Trail sections;
- Protect high public profile Trail sections;
- Protect a section of Trail that would provide recreational access to marginalized communities;
- Have matching funding and involve partnerships with other organizations and agencies;
- Present a high likelihood of success.

As a condition of a grant from the Trail Protection fund, NCTA may, at its discretion, require performative agreements or contracts to ensure that the use of the funds is consistent with NCTA's policy goals in permanently protecting the North Country National Scenic Trail.
