IN 2020, 988 VOLUNTEERS REPORTED 91,000 VOLUNTEER HOURS SUPPORTING THE MISSION. THE ASSOCIATION FOCUSED ON TRAINING AND GUIDANCE OF OUR VOLUNTEERS IN RESPONSE TO THE PANDEMIC AND WERE ABLE TO BRING ON TWO NEW REGIONAL STAFF TO SUPPORT THE WORK ACROSS THE TRAIL.

THE ASSOCIATION ALSO HAS A ROLE IN SECURING THE ACCESS FOR THE TRAIL AND PROTECTING THE CORRIDOR. IN 2020, THEY SECURED 17 NEW PERMANENT EASEMENTS AND WORKED WITH MORE THAN 100 PRIVATE LANDOWNERS.
