**NCTA MISSION:** The North Country Trail Association develops, maintains, protects and promotes the North Country National Scenic Trail as the premier hiking path across the northern tier of the United States through a trail-wide coalition of volunteers and partners.



#### **2018 HIGHLIGHTS**

**991 volunteers** contributed **66,834 hours**, representing an incredible **\$1,650,131** contribution to carrying out the mission of the North Country Trail.

### FROM THE EXECUTIVE DIRECTOR AND PRESIDENT OF THE BOARD

#### 2018 WAS AN INCREDIBLE YEAR.



ur volunteers worked harder than ever to build new sections of Trail and maintained thousands of miles of existing Trail. They built new structures, installed new signs, negotiated new easements and led hundreds of hikes to help people connect with the natural world by stepping onto the North Country National Scenic Trail.

NCTA began a new Crew Leader training program to provide the unique skills needed to lead groups of volunteers in the field. We launched the Next Generation Coalition, a group of 18-28 year olds that want to spread the word about the Trail through their networks. We celebrated the 50th anniversary of the National Trails System Act with the addition of a 50 mile challenge to our popular Hike 100 program. And we laid the groundwork for important legislation in US Congress that was passed in early 2019. We released our new technical map series for free download, making them accessible to more people and we continued to expand our network of trail users, partners and supporters which is growing larger every day.

2018 also brought new opportunities to diversify our funding as our donation and grant income continues to grow allowing us to fund more programs and trail projects. Our funding from the National Park Service is steady but our reliance on this funding is continuing to decrease as we grow our other sources of revenue, which gives us more security in an uncertain political climate.

Our donors, partners, volunteers and supporters made all of this possible.

You made it happen and we thank you.

# PROGRAM HGHLIGHTS

#### VOLUNTEERISM

The North Country Trail simply could not exist without the dedication and passion of the volunteers who contribute their time and energy to the Trail.

- 991 Volunteers contributed 66,834 hours in 2018; a private sector value of \$1.6 million.
- Over 50 trainees participated in the new Crew Leader Training programs in Minnesota and Michigan. These new Crew Leaders will help lead Trail work projects and train other volunteers.
- 23 members joined NCTA's newly formed Next Generation Coalition, an effort to engage Generations Y & Z across the Trail.

#### TRAIL BUILDING AND MAINTENANCE

Maintaining the existing miles of Trail and building new and increasingly sustainable trail segments is one of our greatest accomplishments.

- We have recorded 3,129 miles of off-road trail, closer than ever to our 4,600-mile goal.
- Volunteers constructed 51 miles of new North Country National Scenic Trail in 2018 and improved 2,637 miles of the Trail through maintenance efforts.
- 7,644 feet of puncheon and boardwalk were improved during maintenance projects.
- 304 new kiosks and signs were installed across the Trail, providing better information for Trail users.

#### **TRAIL PROTECTION**

Our efforts in Trail Protection are growing year after year and we are doing more than ever before to ensure the Trail is permanently protected and future generations have access to the NCT.

- 24 new Trail Easements and Agreements were established with landowners.
- NCTA completed the Land Trust Alliance's 'Assess your Organization' process to get a more thorough understanding of the needs and successes of our Trail Protection efforts.
- NCTA, NPS and local volunteers celebrated the National Park Service's first land acquisition; protecting 1.5 miles of the Trail in Michigan.
- A Memorandum of Understanding was finalized between NCTA, the National Park Service and Michigan Department of Natural Resources.

#### ADVOCACY

NCTA's Advocacy Team works across the Trail and in Washington DC to follow important legislation and issues affecting the Trail.

- The North Country Trail Route Adjustment Act was passed in the House of Representatives in 2018, which set the stage for its eventual passage in 2019.
- NCTA and partners continue to work closely with the Wayne National Forest to ensure the North Country Trail is considered in their Forest Plan Revision process, setting the standard for other Forests on the NCT.
- We continued to advocate for permanent authorization and full funding of the Land and Water Conservation Fund, a critical program necessary to complete the National Scenic and Historic Trails.

#### OUTREACH AND COMMUNICATION

Sharing our story with the public allows us to introduce the Trail to new supporters and engage our community on a deeper level.

- NCTA Chapters and Affiliates led 245 hikes and hosted and attended 125 outreach events to promote the Trail.
- NCTA continues to strengthen its online and social media presence with more content that's more diverse, interesting, and engaging. At the end of 2018, the NCTA Facebook page had nearly 17,000 likes and followers. Our @northcountrytrail Instagram account had 4,000 followers and our website, northcountrytrail.org, supported nearly 17,000 active users per month.

#### TRAIL USE

As the nation's longest National Scenic Trail, the NCT can be easily accessed in 8 states and provides countless ways to enjoy and experience nature.

- 17 sets of Technical Series maps were published and made available for free download. The maps were downloaded 13,487 times in 2018.
- NCTA continued the Hike 100 program, encouraging hikers to log 100 miles on the NCT and added a Hike 50 program in 2018 to celebrate the 50th Anniversary of the National Trails System Act. More than 1,000 people from 24 states earned their patches for completion and many more participated in the program.

### The future of the Trail depends on those that come after us.

In 2018 the North Country Trail Association launched a Next Generation Coalition to connect a new generation of trail lovers with the goal of getting more young people involved in outreach, volunteerism and advocacy.

This initiative provides a peer to peer experience and offers great opportunity for the growth and development of the Trail and the organization as well as the personal and professional growth of members of the coalition. Next Generation Coalition members are learning how to connect with the NCT community and gain experience in communication, advocacy initiatives and getting boots-onthe-ground exposure on the Trail itself. "The prioritization and health of public land depends on the actions taken by the next generation of environmental stewards. Young people are at such an advantage to live in a time when communication is efficient, and the desire to do something for a cause is fierce. I believe young people will make a positive difference in an age where media and culture meet nature."

#### **2018 FINANCIAL HIGHLIGHTS**

 he financial sustainability of the North Country Trail Association continued to grow stronger in 2018.

We saw growth in both overall membership numbers and amounts of major gifts. We've also increased our ability to build relationships with Foundations and Corporations and to seek government grants, all areas that performed well and improved from the previous year.

We have made significant progress on our goal to decrease our dependence on the National Park Service and those funds now make up only 33.1% of our revenue stream. We've also begun to build an Operating Reserve to strengthen the organization's ability to weather unexpected expenses or loss of income without cutting into our programs.

Our major program areas of trail awareness, advocacy, trail building, maintenance and protection were all well supported by our revenues. More money went out to the field and onto the Trail than ever before. Due to solid financial management and the significant charitable support of our many donors, the NCTA was able to fund and fulfill its mission and a quick look at our net income shows an organization that is moving into 2019 in a strong position.



The North Country Trail Association holds the "Accredited Charity" rating from the Better Business Bureau. The rating means that the NCTA maintains or exceeds the Wise Giving Standards for Charity Accountability established by the BBB.




